

Wests Tigers RLFC Pty Ltd Grassroots to Greatness Competition Terms and Conditions – Game of Skill

PROMOTERS' DETAILS

- This competition is being run by Zurich Financial Services Australia Limited (ABN 11 008 423 372) 118 Mount St, North Sydney NSW 2060 (Zurich) in conjunction with Wests Tigers Rugby League Football Pty Ltd (ABN 49 090 076 403) Zurich Centre, Loftus St Concord, NSW 2137 (West Tigers).
- For the purpose of these terms and conditions, both Zurich and Wests Tigers may be collectively referred to as the (**Promoters**).

ELIGIBLE ENTRANTS

- To enter this competition, an entrant must meet the requirements set out below.
- An individual (Eligible Entrant) may enter on behalf of their Community junior team sporting organisation that participates in a local Australian Rugby League competition across Australia (Clubs).
- An Eligible Entrant must:
 - be over the age of 18 years at the date of entering the competition, or have permission from their parent or legal guardian to enter;
 - must reside in Australia; and
 - not be staff of Zurich or Wests Tigers; or an immediate family member of staff of Zurich or West Tigers.
- A limit of one entry, per Club to the competition applies. In the case of multiple entries from a Club being received, the first entry received only will be considered.

HOW TO ENTER

• The competition period commences at 12.01am AEDST on Friday 5 July 2024 and ends at 11:59pm Thursday 19 September 2024 (**Competition Period**). The Promoters reserve the right to extend the Competition Period at any time (subject to regulatory approval, if required).

- To enter the competition, Eligible Entrants must during the Competition Period, visit the competition page or https://www.campaignware.com/weststigers/g2gzurich and correctly complete all mandatory fields housed within the competition page.
- Included within the competition page is a requirement to fill in a 25 word or less answer as to why your Club best deserves the Grassroots to Greatness training pack.
- Eligible Entrants must fill in their full name, Junior Club name, contact number, email address, and state as a requirement as this information will be used as contact details for all successful recipients for the Grassroots to Greatness training pack.
- No late entries will be accepted.
- Incomplete, indecipherable, or illegible entries will be deemed invalid and may be rejected. The Promoters reserves the right to disqualify any entry where it reasonably suspects that such materials are prohibited by these terms and conditions, any relevant law, or are otherwise deemed inappropriate. This is at the Promoters' absolute discretion.

SELECTION OF WINNER

- One Club will be selected as a "winner" for each try scored by the Wests Tigers NRLW team during the 2024 NRLW home and away season, up to a maximum of the total number of prizes offered by the Promoters during this competition (see the "Prizes" section below).
- This competition is a game of skill.
- Winners will be chosen by a judging panel selected by the Promoters.
- Judging will take place in the following "rounds":
 - the first judging round will take place on 26 August 2024 (First Judging Round); and
 - the second judging round will take place on 23 September 2024 (Second Judging Round).
- Eligible Entries judged in the First Judging Round are eligible for consideration in subsequent judging rounds.
- The total number of winners for each judging round will correspond with the total number of tries scored by the West Tigers NRLW team during the 2024 NRLW home and away season before each judging round takes place, up to a maximum of the total number of prizes offered by the Promoters during this competition (see the "Prizes" section below).
- During each judging round, the judging panel will review all Eligible Entries submitted before judging takes place. The judging panel will review each eligible entry on the originality, authenticity, and creativity of the 25 word or less answer provided as part of the competition form. The judging panel will then rank those Eligible Entries in order of most to least original, authentic, and creative (**Ranking**). Prizes will then be awarded in the order of the Ranking. For example, if there are 20 prizes allocated to a judging round, those prizes will be awarded to Clubs of the top 20 ranked Eligible Entries.

- The winners will be notified by email or telephone by Wests Tigers by the Monday following the relevant judging round.
- The winners will be asked to provide a contact name and postal address for the Club that they have nominated, so that they prize pack can be mailed to them.
- The results of the draw will be final and binding and no correspondence will be entered into in relation to the results of the judges' decision.

RUNNER-UP WINNERS

 If a winner does not respond within 7 days of being notified that they have won one of the Grassroots to Greatness training packs and reasonable efforts have been made by the Promoters to contact the winner, then the winner will automatically forfeit their prize. The Promoters reserve the right to award the relevant prize to the next best Eligible Entry that has not already been awarded a Prize, as per the Ranking for the relevant judging round.

PROMOTION AND MARKETING

- By entering the competition, the winner agrees to participate in such promotional activity and material as the Promoter may reasonably require without remuneration.
- Activity may include but is not limited to; filming or photography at the winners Junior Rugby League Club, profiling player or volunteer stories from your Club and publishing this material on Wests Tigers or Zurich media and/or social media channels.
- Should promotional requests involve persons under the age of 18, the Promoters and successful club will seek appropriate permission from the child's guardian before commencing promotional activity.

PRIZES

- There are up to 39 separate 'Grassroots to Greatness Training Pack' prizes on offer.
- It's the Promoter's sole discretion to increase the number of Grassroots to Greatness Prize Packs throughout the 2024 NRLW season. Should the Promoter increase prize packs the prizes will be allocated to the next judging round.
- Each Grassroots to Greatness Training Pack comprises:
 - 10 x Steeden footballs (mod size);
 - 1 x collection ball bag; and

- 20 x training bibs (10 of one colour, 10 of another colour).
- Each prize has an estimated retail value of \$550 each AUD.
- Total estimated prize pool equals \$22,000 AUD, if all 39 prize packs are given away.
- The prize will not be transferable to another person or Club without consent of the Promoters.
- No part of a prize is exchangeable or redeemable for cash or any other prize.
- If the prize is not available for any reason, the Promoters reserve the right to substitute the prize with another item of equal or greater value if the winner agrees in writing and subject to any written directions from any applicable regulatory authority.
